The petitioner in the present writ petition filed under Articles 226/227 of the Constitution of India seeks grant of pension and other remaining pensionary benefits, especially the amount of Rs.6,98,178/- alongwith interest @ 9% per annum from the date when it became due. The relief claimed is stated to be covered by the order dated 16.01.2020 passed in **CWP No. 5451 of 2019 'Nishan Singh Vs. State of Punjab and others'** (Annexure P-10).

It is the case of the petitioner that he was appointed as a Pump Operator in the Department of Water Supply and Sewerage Board, Division Ferozepur on 18.05.1988, on ad-hoc basis. His services were regularized on 18.05.1993 and, thereafter, he was transferred to the Municipal Council, Fazilka-respondent No.4 on 01.04.1998. He retired on 31.07.2017 after availing one year extension in service.

Counsel for the petitioner has submitted that a detailed legal notice dated 15.09.2020 (Annexure P-12) has already been served upon the respondents and he would be satisfied if the same is decided within a fixed time frame.

Keeping in view the fact that the decision making is incomplete, this Court is of the considered opinion that it is not necessary to call upon the respondents for filing reply, as it would delay the proceedings.

Accordingly, without commenting upon the merits of the case and the entitlement as such of the petitioner, the present writ petition is disposed off with the direction to respondent No.2 to decide the representation of the petitioner within a period of 3 months from the date of the receipt of the certified copy of this order. In case, the amount is payable to the petitioner, the said amount be paid thereafter within a period of 2 months. In case, there is any legal impediment as such and the amount is not liable to be paid, reasoned order be passed and communicated to the petitioner forthwith.
