Prayer in this petition is for grant of regular bail in FIR No.307 dated 08.03.2020 under Sections 307, 323, 379-B, 506 IPC, registered at Police Station City Thanesar, District Kurukshetra.

On 19.11.2020, following order was passed by this Court: -

“The matter has been taken up through video conferencing in the light of COVID-19 pandemic.

Learned counsel for the petitioner has submitted that the bail applications of fellow accused bearing CRM-M Nos. 34658 and 20426 of 2020 are pending for 21.12.2020 and they have been extended benefit of interim bail even though they have been named in the FIR. It is also submitted that the present petitioner has not been named in the FIR and he has been nominated as accused subsequently in pursuance of the disclosure statement made by the fellow accused.

Compromise is stated to have been effected between the parties, copy whereof is placed on record as Annexure P-2.

In these circumstances, learned State counsel seeks adjournment as she intends to verify about the arrival of the compromise between the parties.

List on 21.12.2020. To be taken up alongwith the aforesaid two connected petitions.

In the meanwhile, the benefit of interim bail is granted to the present petitioner in the present case till the next date of hearing on his furnishing adequate bail and surety bonds subject to the satisfaction of learned trial Court/Duty Magistrate concerned.”

Learned counsel for the petitioner submits that the matter stands compromised between the parties as per the compromise deed dated
