AUGUSTINE GEORGE MASIH, J. (ORAL)

Petitioner has approached this Court pointing out a grievance that a plot was allotted to the petitioner measuring 83.60 square meter (4 *marla*) i.e. Plot No.889, Sector 52, Gurugram. The said plot being disputed and being not available for giving possession to the petitioner, her case for allotment of an alternative plot was taken up. Despite efforts being made by the petitioner for the allotment of an alternative plot, till date the same exercise has not been completed. Petitioner has put forth a grievance that now E-auction of plots measuring 4 *marla*, Sector 52, Gurugram, is being carried out. Counsel for the petitioner asserts that all these plots are, if sold out, there will be no alternative plot, which could be allotted to the petitioner in lieu of the disputed Plot No.889, Sector 52, Gurugram. Petitioner has submitted a representation dated 01.10.2020 (Annexure P-12) to the Estate Officer-II, Haryana Shahari Vikas Pradhikaran, Gurugram-respondent No.2 and the Chief Administrator,

Haryana Shahari Vikas Pradhikaran, Panchkula-respondent No.1 but till date the same has not been decided.

Counsel for the respondents is unable to inform the Court as to whether any decision on the said representation has been taken till date or not.

Keeping in view the above facts and circumstances of the present case, the present petition is disposed of with directions to the Chief Administrator, Haryana Shahari Vikas Pradhikaran, Panchkula-respondent No.1 and Estate Officer-II, Haryana Shahari Vikas Pradhikaran, Gurugram-respondent No.2 to consider and decide the representation dated 01.10.2020 (Annexure P-12) submitted by the petitioner within a period of two weeks from today.

In the meanwhile, till a decision is taken on the said representation, one plot be kept reserved for the petitioner out of the plots up for sale under the E-auction process in Sector-52, Gurugram.
