GIRISH AGNIHOTRI, J. (Oral)

Petitioners – Sanjay Malik and Parvinder, have jointly filed the present petition *inter alia* with a prayer to direct the respondent to make necessary correction in the MIS profile of the petitioners as the School where the petitioner No.1 served from year 2011 to 2013 and petitioner No.2 served from 2011 to 2016 falls in zone 7 as other teachers who have served in the same school have given benefit of zone 7 and the zoning of school has been created in implementation of transfer policy dated 29.06.2016 (Annexure P-1) and respondent be directed to count the services of the petitioners in zone 7 instead of zone 2.

Learned counsel for the petitioners based on pleadings, submits that vide circular dated 03.06.2016 (Annexure P-2), the schools were divided into zones as per the Policy 2016. Learned counsel further submits that the respondent department, have redefined the zones and made subsequent changes in the zones, as a result of which, where the petitioners

have served during the year 2011 to 2013 and 2011 to 2015 respectively, were moved to zone 7. Learned counsel for the petitioners then submits that for the same/similar grievances, the petitioners had submitted a representation dated 18.08.2020 (Annexure P-7), but till date no action has been taken. Learned counsel also submits that the petitioners would like to submit a supplementary comprehensive representation within a week from today.

Notice of motion.

On the asking of Court, Mr. Ravinder Budhwar, Addl. A.G., Haryana, accepts notice on behalf of respondents No. 1 to 4-State.

In view of the above and without commenting on the merits of the case, the present petition is disposed of with a direction to respondent Nos.3 and 4 i.e. Director of Secondary Education, Haryana, Panchkula and Director Elementary Education, Haryana, Panchkula, to consider the representation dated 18.08.2020 (Annexure P-7) and also supplementary representation, so submitted, and decide the same in accordance with law, as expeditiously as possible, preferably within a period of 06 weeks from the date of receipt of certified copy of this order.

Ordered accordingly.
