Case has been taken up for hearing through Video Conferencing.

This petition under Section 482 Cr.P.C. read with Section 439 Cr.P.C. is for grant of interim bail to petitioner-**Kulwinder Singh @ Kindi** in case FIR No.49 dated 28.02.2020 under Sections 21 and 29 of NDPS Act, registered at Police Station Phillaur, District Jalandhar, for a period of one week to attend *shagun* and marriage ceremonies of his sister Ms. Rita, which are scheduled for 28.11.2020 and 29.11.2020.

Custody certificate filed by learned State counsel is taken on record.

Status report of even date, by way of short affidavit of Sanjeev Kapoor, Inspector, Station House Officer, Police Station Phillaur, District Jalandhar (Rural), filed on behalf of respondent No.1-State, is also taken on record.

Learned State counsel on the basis of status report submits that on verification from quarter concerned “*Mel*” ceremony in respect of marriage of Ms. Rita, sister of petitioner, is to be held on 28.11.2020 and the marriage ceremony of said Ms. Rita will be held on 29.11.2020. He further submits that since petitioner is involved in heavy quantity of narcotics (11 kgs heroin), he (petitioner) may be permitted to be taken in custody to attend the marriage of his sister.

In view of above, instant petition is disposed of with the direction to Superintendent, Central Jail, Kapurthala, to make necessary arrangements so that petitioner-**Kulwinder Singh @ Kindi** is taken in custody to Sadar Road Milan Palace, Makhoo (marriage venue) at 7:00 AM sharp on 29.11.2020 and after attending marriage ceremony, he shall be taken back to the Central Jail, Kapurthala, on the same day well before evening hours. Senior Superintendent of Police, Kapurthala, shall also make necessary arrangements as petitioner is to be taken in custody during the course of travel from Central Jail, Kapurthala to Makhoo and back. Requisite intimation be sent to quarters concerned for strict compliance.
