The hearing of the case was held through video conference on account of restricted functioning of the Courts.

On 16.12.2020, the following order was passed:-

The hearing of the case was held through video conferencing on account of restricted functioning of the Courts.

A reading of Annexure P-6, the communication dated 13.10.2020, it is apparent that the aforesaid communication has been issued on the basis of a letter issued by learned Deputy Commissioner, Kurukshetra.

The grievance of the petitioner is that he although is an elected Sarpanch, but is being repeatedly harassed by making him to face multiple enquiries on the same subject matters. He submits that previously, the enquiry has already been held by the Deputy Chief Executive Officer, Zila Parishad, Kuruskehtra, Annexure P-3. He further submits that on the basis of aforesaid enquiry report, a show cause notice was issued to the petitioner which was responded to. However, thereafter, the petitioner has received communication dated 13.10.2020 directing him to produce the entire record of the Gram Panchayat before the Executive Engineer, Haryana State Agricultural Marketing Board, Kurukshetra. He apprehends that on a fresh complaint, a new enquiry has been initiated on the same allegations which have already been enquired into.

Mr. Samarth Sagar, Addl. A.G.,Haryana, who is present in court has been requested to provide a copy of

the communicated dated 06.10.2020 for perusal of the Court and take complete instructions. List on 18.12.2020.”

Mr. Samarth Sagar, Additional Advocate General, Haryana, on instructions from Mr.Sahab Singh, Block Development and Panchayat Officer, Thanesar, has stated that since in the previous enquiry, no clear report was submitted with regard to allegation no.5, therefore, the Deputy Commissioner, Kurukshetra considered it appropriate to direct Executive Engineer, Haryana State Agricultural Marketing Board, Kurukshetra, to enquire into the allegation no.5. He submits that no fresh enquiry on a fresh complaint has been ordered.

Keeping in view the aforesaid facts, no ground to issue the writ as prayed for. It shall be open for the petitioner to take all defences before the authorities.
