Application has been filed for bringing on record the legal heirs
of deceased original appellant Jugal Kishore. It is stated that the said appellant

had expired on 21.05.2012 leaving behind his legal heirs as mentioned in para No.3 of the application, who are stated to be the only legal heirs of deceased appellant. It is further stated that there are no other legal heirs of the deceased appellant except ones mentioned in para No.3 of the application. Copy of death certificate is appended as Annexure A-1.

Accordingly, in view of the averments made in the application, duly supported by affidavit of Santosh Arora widow of deceased-appellant, same is allowed subject to all just exceptions. Legal heirs as mentioned in para No.3 of the application are brought on record and permitted to pursue the present litigation only. It is made clear that the present order will not be liable to be taken into consideration in any other set of proceedings.

CM stands disposed of.
