Prayer in this application has been made for exemption from filing certified copy of the Annexure P-A/1 and also to place on record the translated copy of the same.

The application is allowed and exemption is allowed and Annexure P-A/1 which is office order dated 01.11.2019 is taken on record subject to just exceptions.

CM-1977-2020

CM is allowed and additional affidavit of the petitioner is taken on record.

Main Cases:-

It is not disputed that during the pendency of the writ petition, the seniority list with regard to the Planning officers and Degree Holders who form the Feeder Cadre, has been recast and the seniority lists are dated 29.05.2019 and 01.11.2019, respectively. This has been so done in pursuance to the order dated 01.10.2015, initially passed while issuing notice of motion in CWP No. 21044 of 2015.

In the light of the above, the writ petitions have been rendered infructuous.

Disposed of as such.

However, learned counsel for the petitioners in CWP No. 22330 of 2015 states that the petitioners are aggrieved by the above seniority lists which have been recast as they have been wrongly shown junior to the candidates who had joined Feeder Cadre later than the petitioner. Liberty has been prayed to challenge the same.

Prayer granted.

Petitioner may avail of the remedies in accordance with law including challenging of the seniority list.

Since the main cases have been disposed of, all the pending applications, if any, also stands disposed of as infructuous.
