Prayer in the instant petition under Section 482 Cr.P.C. has been made for quashing of FIR No. 182, dated 29.05.2018, registered under Section 8B National Highway Act 1956 and Sections 147, 149, 323, 341, 506 IPC at Police Station Madhuban, District Karnal and all subsequent proceedings arising therefrom, on the basis of compromise deed dated 19.10.2018 (Annexure P-6) effected in between the parties.

Pursuant to orders dated 25.10.2018 of this Court, the parties appeared before Additional Chief Judicial Magistrate, Karnal, on 12.11.2018 to get their statements recorded. Learned Additional Chief Judicial Magistrate, Karnal, submitted his report vide letter No. 634 dated 17.11.2018 duly forwarded by the learned District and Sessions Judge, Karnal, vide letter No. 17364 dated 17.11.2018.

According to the report, learned Additional Chief Judicial Magistrate, Karnal, is satisfied that compromise effected between the parties is genuine one, without any pressure or out of their own will.

In compliance of order dated 17.02.2020, original receipts regarding deposit of costs of Rs. 10,000/- have also been produced in Court today. The same are taken on record. Be tagged at appropriate place.

Considering the report of Additional Chief Judicial Magistrate, Karnal, dated 17.11.2018 and deposit of costs as well as the fact that the compromise will bring peace and harmony between the parties, aforesaid FIR No. 182 dated 29.05.2018 (Annexure P-1) and all subsequent proceedings arising therefrom, are quashed, qua the petitioners only.

Registry is directed to verify deposit of aforesaid costs, with the concerned quarter.

Disposed of, accordingly.
