1. This petition has been filed for issuance of a writ in the certiorari for quashing the order dated 20.7.2019 passed by the Superintendent of Prison, District Prison Karnal (Annexure P-2) wherein the plea of the petitioner seeking temporary release in the form of parole was declined.

2. On 10.12.2019 the following order was passed :-

“Learned counsel for the petitioner informs that the petitioner is experiencing pain and discomfort on account of bullet lodged in the head and he was examined on 02.09.2019 by the surgeons of AIIMS Hospital, Delhi and a review was to be made after six months. However, keeping in view the aforesaid assertion, the petitioner be again examined and a definite opinion in this regard be sought from the said hospital whether immediate surgery or any

invasive procedure is required upon the petitioner or not.
Post again on 13.01.2020.”

3. Today, medical report dated 12.1.2020 has been filed by Sher Singh, Superintendent of Prison, District Prison, Karnal on behalf of respondents, the same is taken on record. Copy has been supplied to the opposite party. As per the medical report, the petitioner was again taken to AIIMS Hospital, Delhi on 6.1.2020 and the Doctor reported that no surgical intervention is required at this stage and the condition is to be reviewed after three months.
4. Counsel for the petitioner however states that this information is incomplete because as per him after 6.1.2020 the petitioner has twice been taken to AIIMS Hospital, Delhi because of some medical conditions and this fact has not been reflected. To this, learned State counsel has confirmed from Sanjay Bangar, Deputy Superintendent, District Jail, Karnal that after 6.1.2020 the petitioner was not taken to AIIMS Hospital, Delhi.
5. In view of these circumstances, the present petition stands dismissed.
6. Since the main case has been dismissed, the pending application, if any, also stands disposed of.
