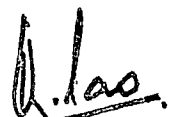

I have been informed that the final arguments are being advanced by the parties.

Even though, Mr. Salwan, learned counsel appearing for the petitioner(s) seeks 18 months time for the learned sole Arbitrator to render the award, this Court is of the view that the time sought is not reasonable and appropriate shall be that the time be extended by one year to enable the learned sole Arbitrator to complete the proceedings and render the award effective from June 01, 2020.
