4 17-03-2021 Petitioner has prayed for the following relief(s):-

“For issuance of a writ in the nature of Habeas Corpus or any other appropriate writ(s), Order(s), direction(s) to recover/release the minor daughter of the petitioner, who is in illegal confinement of Private respondent No. 7 and 8 and produce the Corpus before the Hon’ble Court or even after



lodging of First Information report bearing registered as Bahadurpur P.S.Case No. 09/21 dated 9.1.2021 under Sections 363, 366(A) of the Indian Penal Code. Police is not taking sincere steps to secure release of petitioner's minor daughter namely Saumya Singh from the illegal detention of respondent No. 7 & 8."

Learned counsel for the petitioner seeks permission to withdraw the present petition for the reason that post notice the present petition has become infructuous as also the corpus of the prosecutrix stands recovered.

Permission granted.

Present petition stands dismissed as withdrawn.
