“For issuance of a writ of mandamus directing the respondents to reduce and restrict the value of entire Performance Security to 3% including Performance Bank Guarantee (PBG), Security Money (SD), and Retention Money, without seeking equivalent amount of Bank Guarantee for release of Security money and Retention money, in the left over portion of existing contract value as per Office Memorandum (OM) issued by Government of India, Ministry of Finance dated 12.11.2020 & 13.05.2020 and the Petitioner further pray for direction to Respondent authorities for any other relief/ reliefs for which the Hon’ble Court may deem fit and proper.”

Learned counsel for the petitioner seeks permission to withdraw the petition.

Prayer allowed.

The petition is dismissed as withdrawn.
