“1.(A) A certiorary for setting aside the
order dated 24.5.2011 (Annexure-2) passed by
the Members Appellate Authority District
Teachers Appointment, Madhubani,
(Respondent No.2) whereby Appeal case No. 83
of 2005 filed for irregularity in appointment of
Shiksha Mitra in Gram Panchayat Gangapur P.S.
Lakhsaur, District-Madhubani has been dropped



on the ground of the pendency of C.W.J.C. No. 5289 of 2008 filed by Mintu Kumar (Respondent no.7)

(B) A Mandamus Commanding the Respondents to Proceed with Appeal Case No. 83 of 2005 Pending before, Appellate Authority (Respondent No.2) and disposed it of by a reasoned order.
