2 15-09-2021 This application is filed for modification of order dated 04.02.2020 passed in Cr. Misc. No. 2161 of 2020, by which petitioners were allowed anticipatory bail in connection with Goh P.S. Case No. 18 of 2019 pending in the Court of C.J.M., Aurangabad.
