Heard learned counsel for the parties.

Petitioner has prayed for the following relief(s):-

- (i) To issue an appropriate order/s, direction/s including a writ preferably in the nature of CERTIORARI for quashing of the decision dated 04-02-2020 passed in Exclusive No. 999930231121803213/2A by the Principal Secretary, Agriculture Department, Bihar, Patna the



Second Appellate Authority under the Right to Public Grievance Redressal Act, 2015 whereby and where under he has rejected the second appeal filed by the petitioner and did not interfere in the matter of not issuing crops Insurance as well as charging interest @ 12 % in place of 7 % against K.C.C. loan amount vide Account No. 32462193952 which was classified as N.P.A. account by the respondent State Bank of India.

- (ii) To quash the decision dated 10-12-19 passed by the Divisional commissioner, Tirhut Division, Muzaffarpur first appellate authority under the Right to Public Grievance Redressal Act, 2015 in Exclusive No. 999930231121803213/2A whereby and where under he has rejected the appeal filed by the petitioner and also did not interfere in the matter of charging interest @ 12% in place of 7 % against the aforesaid KCC loan amount and not regularizing the crops insurance.
- (iii) To quash the order dated 20-02-2019 passed in Complaint No. 999930231121803213/2A passed by the Additional Collector, Muzaffarpur (Hereinafter referred to as Public Grievance Redressal Officer under Right to Public Grievance Redressal Act, 2015 whereby and where under he has dropped the proceedings rejecting the claim of the petitioner for issuance of crops insurance and retaining the rate of interest 7% in the K.C.C. Loan account.
- (iv) To direct the respondent No. 6 and 7 to redress the grievance of the petitioner and retain the rate of interest i.e. 7% in the K.C.C. Loan account and issue crops Insurance so that insurance amount be paid.
- (v) To any other relief/s to which the petitioners are entitled in the facts and circumstances of the case.

Learned counsel for the petitioner states that the



matter stands settled in the Lok Adalat on 11<sup>th</sup> of December, 2021, as such, the present petition has become infructuous.

Statement accepted and taken on record.

The present writ petition stands disposed of as withdrawn.
