Heard learned counsel for the parties.

Petitioner has prayed for the following relief(s).

“That this is an application to quash the order dated 15.10.2019 passed by the Respondent No. 2 by which the permanent stage carriage permit has been granted to respondent-no. 5 for the route Biharsarif to Patna via Noor Sarai- Chandi after cutting the objectionable 1st trip i.e. Biharsarif to Patna via Noorsanai Chandi but the permit has been issued after cutting the 1st trip from Biharsarif to Chandi and third dn. trip of the said permit on Bus No. BR21P-4227.”

Petitioner has approached this Court without

exhausting the statutory remedy of appeal against the impugned order, as such, petitioner is granted liberty to avail the remedy of appeal against the impugned order before the concerned authority and if any such appeal is filed within 4 weeks then concerned authority shall condone the delay in filing the appeal, as the matter remained pending before this Court and shall decide the appeal on its own merit preferably within 8 weeks from the date of its filing

With aforesaid liberty, the writ petition is disposed of.
