4      08-12-2021                      Once again when the matter is called out, Mr. Navin Kumar Singh, learned counsel makes a prayer for adjournment in the name of non-availability of Mr. Sangeet Deokuliar, who is the Advocate on Record on behalf of the petitioner.

Mr. Bindyachal Singh, learned Senior Counsel represents the Patna Municipal Corporation. Learned Senior Counsel submits that he was waiting in the Court room for some



time but was never informed that the learned counsel for the petitioner is likely to seek any adjournment.

Mr. Dilip Kumar, learned A.C. to G.A.-3 for the State is present.

On the last date i.e. on 24.11.2021 when a prayer for adjournment was made on behalf of the petitioner, this Court recorded the following order:-
