After some arguments, learned counsel for the petitioner decides not to press this application in view of the facts and circumstances of the case.

Our attention, however, has been drawn towards the part of the impugned order dated 08.08.2013, whereby the Patna Branch of Central Administrative Tribunal has issued a fresh direction in the contempt proceeding for arranging special examination for the respondent.

This application, in peculiar facts and circumstances of the case, is disposed of as not pressed with a liberty to the respondent to seek adjudication before the appropriate forum, as to for whose fault, the respondent failed to appear at the special examination fixed for him in terms of an order of the Tribunal.
