This modification application has been filed for
modifying the order dated 13.07.2020 passed in C.W.J.C. No.
4643 of 2020 passed by Hon'ble the Chief Justice and Hon'ble
Mr. Justice S. Kumar.

It is submitted that due to typographical error P.S.
name has wrongly been typed as "Bakhri P.S." in place of
Allouli P.S." and respondent no. 4 has been wrongly typed as
the "Suprerintendent of Police, District of Begusarai, Bihar" in



place of “Superintendent of Police, District of Khagaria, Bihar.”
