4 01-03-2021 The present petition has been filed seeking transfer of Guardian Case No. 07 of 2018 (Suresh Kumar Prasad vs. Srimati Mala Prasad & Ors.) from the Ld. court of Principal Judge, Family Court, Samastipur to the Ld. court of Principal Judge, Family Court, Darbhanga.

The learned counsel for the opposite parties has appeared and has submitted that though he has no objection to transfer of the case, but a time frame may be fixed for disposal of the aforesaid Guardian Case No. 07 of 2018 and



further, he seeks liberty to approach the learned court below for grant of visitation rights.
