This petition has been filed for modification of order dated 18.12.2020, passed in Cr.Appeal (SJ) No.1942 of 2020.

It is submitted on behalf of the petitioners that due to inadvertence, name of the petitioner no. 10 has wrongly been mentioned in the cause title of the aforesaid order as Arjun Mandal in place of Ajen Mandal.
