2 15-12-2021 Heard Mr. Anant Kumar Mishra, learned Advocate for the petitioners and Mr. Ajit Kumar, learned APP for the State.

The petitioners seek modification of the order dated 09.04.2021 passed in Cr. Misc. No. 37457 of 2020.

Learned counsel for the petitioners has



submitted that because of Covid-19 Pandemic, they could not surrender within the stipulated time before the court below to take advantage of the order.

For the reasons stated in the application, the prayer for extension of time for surrendering of the petitioners before the court below is allowed.

The order is modified to the extent that if the petitioners surrender before the learned court below within a period of four weeks from today, they will be accorded the privilege under the order dated 09.04.2021 on the same terms and conditions.
