2 15-11-2021 Heard learned counsel for the petitioner and the State.

Learned counsel for the petitioner is directed to remove the defect(s), as pointed out by the office, within a period of eight weeks.

The present application has been filed for modification of the order dated 12-08-2021 passed in Cr. Misc. No. 6004 of 2021 by which the petitioner was granted anticipatory bail in connection with Ara Muffasil P.S. Case No. 29 of 2020 pending in the court of learned Additional Chief Judicial Magistrate-VIII, Ara, Bhojpur.

It is submitted on behalf of the petitioner that inadvertently, in paragraph-1 and prayer portion of the bail application (Cr. Misc. No. 6004 of 2021), Ara Muffasil P.S. Case No. 20 of



2020 has wrongly been mentioned in place of Ara Muffasil P.S. Case No. 29 of 2020 and due to that, same mistake occurred in the order dated 12-08-2021 passed in Cr. Misc. No. 6004 of 2021 and that is why, the petitioner could not surrender in the court below within the stipulated time. It is further prayed on behalf of the counsel for the petitioner that the first and the last paragraph of the order dated 12-08-2021 passed in Cr. Misc. No. 6004 of 2021 be modified and further time may also be extended so that the petitioner could surrender in the court below.

Considering the submissions made on behalf of the learned counsel for the petitioner and the grounds mentioned in the modification application, the order dated 12-08-2021 passed in Cr. Misc. No. 6004 of 2021 is modified to the extent that in the first and the last paragraphs of the order, “***Ara Muffasil P.S. Case No. 20 of 2020***” mentioned in the order be read as “***Ara Muffasil P.S. Case No. 29 of 2020***” and the period of surrender of the petitioner in the court below is extended for a further period of eight weeks from the date of receipt/production of a copy of this order. The rest of the conditions shall remain the same as mentioned in the order dated 12-08-2021 passed in Cr. Misc. No. 6004 of 2021.



The order dated 12-08-2021 passed in Cr. Misc. No. 6004
of 2021 is modified to the extent as indicated above.

The modification application is, accordingly, disposed of.
