ORAL ORDER

2 26-03-2021 The present writ petition has been filed seeking the following reliefs:-

"(i) For a direction to the authority concern (Respondent No. 5 and Respondent No. 6) to remove the encroachment made by its officer over the petitioner's land pertaining to Mauza-Makhopur, Thana No. 534,



Tauzi No. 3973, Khata No. 18,
Khesra No. 26, Area-1 Katha 8 Dhur
under District of Begusarai.

(ii) For a direction to the authority
concern (Respondent No. 5 and
Respondent No. 6) to compensate
the petitioner for holding his land
unauthorisedly for a long period.

(iii) For any other relief or reliefs for
which the petitioner is entitled in
law be given to him."

At the outset, the learned counsel for the
petitioner has submitted that the petitioner would
be approaching the Managing Director, Bihar
Industrial Area Development Authority, Bihar,
Patna for redressal of his aforesaid grievances.

Accordingly, the present writ petition
stands disposed of with liberty to the petitioner to
approach the Managing Director, Bihar Industrial
Area Development Authority, Bihar, Patna, by filing
appropriate representation within a period of two
weeks from today, which shall be disposed of by
the Managing Director, Bihar Industrial Area
Development Authority, Bihar, Patna, within a
period of six weeks, thereafter in accordance with



law.
