learned A.P.P. for the State.

The petitioners apprehend their arrest in connection with Madanpur P.S. Case No. 172 of 2020 registered under Sections 147, 148, 149, 341, 342, 323, 354, 354(b), 506, 504, 325 of the Indian Penal Code and Section 27 of the Arms Act.

Learned counsel appearing on behalf of the petitioners submits that petitioners are innocent and have falsely been implicated in the present case. There is no specific allegation against the petitioners. In the instant case, first information report is lodged after lapse of 10 days of the alleged occurrence. Further, submission is that earlier, wife of the petitioner no.11 has also lodged a case against the prosecution party, as contained in Annexure-2 to the bail application, on account of which, they have been made accused in the present case.

Having considered the facts and circumstances of the case, let the above named petitioners be released on bail, in the



event of arrest or surrender before the learned Court below within a period of four weeks from today, on furnishing bail bond of Rs. 10,000/- (ten thousand) each with two sureties of the like amount each to the satisfaction of C.J.M., Aurangabad in connection with Madanpur P.S. Case No. 172 of 2020, subject to the condition as laid down under Section 438(2) of the Cr. P.C.
