and the prayer portion of the application.

Let P.S. case number be read as Harnaut (Gokhulpur  
O.P.) P.S. case No.319/2021 in paragraph 1 and the prayer  
portion of the application.

The petitioner is apprehending her arrest in  
connection with Harnaut (Gokhulpur O.P.) P.S. case



No.319/2021 registered under Sections 304(B), 201/34 of the Indian Penal Code.

Allegation is that the accused persons including the petitioner caused death of the daughter of the informant due to non-fulfilment of demand of dowry.

It has been submitted on behalf of the petitioner that the petitioner has got no criminal antecedent and there is no allegation of tampering of witnesses alleged against the petitioner. The petitioner has falsely been implicated in this case. The petitioner is the mother-in-law of the deceased. She is separate in mess and property from the husband of the deceased. She has got no concern with the alleged occurrence.

On behalf of the State, it is submitted that the petitioner is named in the complaint case/F.I.R.

Considering the facts and circumstances of the case, the petitioner, above named, in the event of arrest or surrender before the learned court below within a period of twelve weeks from today, be released on anticipatory bail on furnishing bail bonds of Rs.10,000/- (Rupees ten thousand) with two sureties of the like amount each to the satisfaction of learned C.J.M., Nalanda at Biharsharif in connection with Harnaut (Gokhulpur O.P.) P.S. case No.319/2021, subject to the conditions as laid



down under Section 438(2) of the Code of Criminal Procedure.
