2 22-09-2021 Heard learned counsel for the petitioners and the learned A.P.P. for the State.

The petitioners apprehend their arrest in connection with Begusarai Nagar (Lohiya Nagar O.P.) P.S. Case No. 721 of 2019 registered under Sections 420, 376, 384, 323 and 506 of the Indian Penal Code and also Section 3 of the Dowry Prohibition Act.

Learned counsel appearing on behalf of the petitioners submits that petitioners are innocent and have falsely



been implicated in the present case. Further submission is that in the instant case, final form has already been submitted and thereafter, cognizance has been taken.

Having considered the facts and circumstances of the case, let the above named petitioners be released on bail, in the event of arrest or surrender before the learned Court below within a period of four weeks from today, on furnishing bail bond of Rs. 10,000/- (ten thousand) each with two sureties of the like amount each to the satisfaction of the Judicial Magistrate, 1st Class, Begusarai in connection with Begusarai Town (Lohiya Nagar O.P.) P.S. Case No. 721 of 2019 subject to the condition as laid down under Section 438(2) of the Cr. P.C.
