2      12-03-2021                      Today, during physical Court proceedings, in the first hour, petitioner's counsel made a mentioning and filed a slip to the effect that the complaint case, out of which, the current quashing application arises, has since been compromised and the complaint case has been closed on 15.01.2021. The



petitioners' counsel had earlier made e-mentioning, in this regard, under the current system, and that even though the mentioning had been allowed, for listing the matter "UNDER THE HEADING TO BE MENTIONED" it has not been done.

It is, under these circumstances, the matter was directed to be listed for consideration through virtual mode in the second half and is currently being taken up.
