- i) To complete the process of selection of Aanganwari Sevika within a time frame at centre No. 259 of Ward No. 4 of Panchayat Pakharam Uttari in a transparent manner considering the case of petitioner, who is at Serial No. 01 in



the merit list and also for quashing the comment made in Abhiyukti column of the merit list dated 04/11/19.

(ii) For also to direct the respondents not to disqualify the petitioner on the basis of earlier order of the District Program Officer, I.C.D.S. Darbhanga passed vide Memo No. 1100 dated 29/05/2019 in earlier selection process, which was later on cancelled.

(iii) For quashing the memo No. 1100 dated 29/05/2019.”

On 21.05.2021, we had passed the following order:

List this matter on 02.07.2021.”
