2 23-12-2021 Petitioner has prayed for the following relief(s):

(I) For quashing of the order dated 16.08.2021 passed by Commissioner, Excise, Bihar, Patna in Excise Appeal Case no. 464/2021, whereby and where under the order passed by Collector, Sheikhpura dated 17.07.2021 in Confiscation Case no. 41/2021, confiscating the seized vehicle (Dzire VXi), bearing registration no. BR-52C-2848, Chesis no. MA3CZF63SKD527363, Engine No. K122353370, has been confirmed and the appeal has been dismissed.



(ii) For quashing the order passed by the Collector, Sheikhpura dated 17.07.2021 in Confiscation Case no.41/2021, whereby the seized vehicle (Dzire VXI), bearing registration no. BR-52C-2848, Chesis no. MA3CZF63SKD527363, Engine No. K122353370, has been confiscated, directing to put the seized vehicle for auction sale.

(iii) For issuance of writ of mandamus commanding the respondent authorities not to put the seized vehicle (Dzire VXI), bearing registration no. BR-52C-2848,

Chesis no. MA3CZF63SKD527363, Engine No. K122353370, on auction sale.

(iv) To stay the operation of Annexures-2 and 3 during the pendency of the present writ petition.

(v) For passing any other order/orders, direction/directions, as this Hon'ble Court may consider fit and proper in the facts and circumstances of the instant case.

Learned counsel for the petitioner seeks permission to withdraw the petition.



Prayer allowed.

The petition is dismissed as withdrawn.

Interlocutory application, if any, shall also stand
disposed of.
