Prasad (GP-13), submits that the matter has been sorted out and the NOC has also been issued to the petitioner, as such, the balance amount of 10 per cent pension and 100 per cent gratuity amount will definitely be paid to the petitioner within a period of four weeks from today.

Accordingly, the present writ petition stands disposed of with a direction to the respondents to pay the balance amount of 10 per cent pension and 100 per cent amount of gratuity to the petitioner within a period of four weeks from today, failing which, the Principal Secretary, Health Department, Bihar, Patna, the District Magistrate, West Champaran, Bettiah and the Civil Surgeon-cum-Chief Medical Officer, West Champaran, Bettiah, shall not draw their respective salary.
