Since common issues are involved in these writ petitions to be decided, by consent of the parties, these matters are taken up for hearing analogously and are disposed of by a common order.

It is submitted by the learned counsel appearing on behalf of the petitioners that their lands were requisitioned in accordance with West Bengal Land (Requisition and Acquisition) Act, 1948 but the lands were not acquired subsequently. In the meantime the West Bengal Land (Requisition and Acquisition) Act, 1948 stood repealed with effect from March 31, 1997.
