1. Proceedings of these matters have been taken-up through video conferencing.
2. Since the common question of law are involved in these writ petitions, they were clubbed together, heard

together and being disposed of by this common order.

3. The petitioner Shikshak Sangh is aggrieved by the order dated 30.7.2009 which has been called in question in Writ Petition (S) No.2416/2010 and the order dated 7.8.2010 which has been called in Writ Petition (S) No.5178/2010 by which private respondents have been promoted from the post of Assistant Teacher to the post of Upper Division Teacher, which have been called in question.
4. Mr.N.Naha Roy, learned counsel appearing for the petitioners, would submit that the order of promotion issued by the respondent-State to the private respondents is unsustainable, bad in law and contrary to the circular dated 4.3.2009, as such, it is liable to be set aside.
5. Mr.Somkant Verma, learned counsel for appearing private respondents in Writ Petition (S) No.5178/2010, would submit that members of the petitioner Association have also been given promotion to the post of Upper Division Teacher in which they are already working.
6. I have heard learned counsel for the parties and considered their rival submissions made hereinabove and also went through the records with utmost circumspection.

7. It is not in dispute that the orders dated 30.7.2009 and 7.8.2010 which have been called in question in these writ petitions have already been given effect to and the private respondents have already joined and working on the said post and after lapse of 10 years, their orders of promotion which have given effect to cannot be interfered with in the instant writ petitions as in absence of interim order by this court, promotion order has already given effect to.

8. In that view of the matter, this Court is not inclined to interfere with the orders of promotion. Accordingly, the writ petitions are disposed of. No order as to cost(s).
