1. It is submitted that the petitioner has filed election petition under Section 122 of the Chhattisgarh Panchayat Raj Adhiniyam, 1993 against respondent No.3. Therefore, it is prayed that a direction be issued to respondent No.2 to conclude the proceeding in the election petition at the earliest.
