PER COURT :

01. These are the applications for condonation of delay moved by the applicant / acquiring body.

02. Heard Mr. Chetan T. Jadhav, learned counsel holding for Mr. Ajay D. Pawar, learned counsel for the applicant / acquiring body, Mr. M.M.Bhokarikar, learned counsel for the original claimant / his legal heirs respondent Nos. 1.5 to 1.6 and Mr. P.M.Kulkarni, learned A.G.P. for respondent No. 2.

03. In all 6 applications, there is delay of 512 days, except in Civil Application No. 2796/2020. In Civil Application No. 2796/2020, there is delay of 180 days in preferring the appeal.

04. Mr. Bhokarikar, learned counsel for the original claimants strongly opposed to condone the delay on the ground that no cogent reasons are assigned for condonation of delay.

05. Having regard to the nature of dispute and for

the reasons stated in the application for condonation of delay in respective matters, the delay needs to be condoned in the interest of justice.

ORDER

(i) The applications for condonation of delay moved by the applicant / acquiring body are hereby allowed.

(ii) The Registry is directed to register the appeals after due scrutiny as per procedure, and thereafter, appeals be placed before the concerned Court for admission

(iii) Respective civil applications seeking stay to proceed further.

(iv) Stand over to 16.12.2021.
