PER COURT:-

1. Learned counsel for the petitioners, on instructions, seeks leave to withdraw all these writ petitions with liberty to the petitioners to approach the Divisional Joint Registrar, Co-operative Societies, Aurangabad to pursue the matters on merits.

2. It appears that enquiry or re-inquiry was never directed by the Divisional Joint Registrar at any point of time. In terms of the provisions of Section 21A of the Maharashtra Co-operative Societies Act, 1960, it is for the Registrar to decide the objection raised for de-registration of the Societies and the Divisional Joint Registrar has undertaken the said task. In view of the same, the petitioner societies shall co-operate the Divisional Joint Registrar for disposal of all such matters, at the earliest. It is not expected from the petitioner societies to delay the matters in any form.

3. In view of above, leave granted. All writ petitions are disposed of as withdrawn.

4. The Divisional Joint Registrar, Co-operative Societies, Aurangabad is hereby directed to dispose of all the proceedings initiated on the basis of objection raised by respondent No.3 as expeditiously as possible.
