ORDER :-

This is an application under Section 482 of the Code of Criminal Procedure.

2. The respondent No.2 herein had filed the complaint case for the offences punishable under Sections 498-A, 323, 504 and 506 read with Section 34 of the Indian Penal Code, which came to be registered as Regular Criminal Case No. 41 of 2019 (old Misc. Criminal Application No. 607 of 2016).
