1. Heard Shri S.B.Deshpande, learned counsel for the applicant Acquiring Body and Shri V.B.Patil, learned counsel for the respondents - claimants.
2. According to Shri Deshpande, learned counsel for the applicant Acquiring Body delay is caused for preferring the appeals because of procedural formalities. He argued that delay is neither intentional nor deliberate.
