PER COURT :-

1. Heard learned Advocate appearing for the appellant (Original claimant). Learned AGPs for Respondent Nos.1 & 2. Though Respondent No.3 is duly served, nobody appears on behalf of the acquiring body.

2. The appellants are the original claimants, who want to challenge the Award passed by the Reference Court for enhancement.
