We are informed that, accordingly most of the District Collectors have concluded the hearing and taken decision, however, in some Grampanchayats, it was noticed that the provisions prescribed by Section 30 (5) of the Maharashtra Village Panchayats Act, 1959 have not been followed and therefore there is a need to change the reservations.
