1. Liquidator has filed an affidavit dated 15th February, 2021 according his no objection to the prayer sought in the application. At the same time, liquidator is referring to compliance of order dated 20th August, 2013 where as application is referring to order dated 3rd May, 2012. Moreover, the affidavit in reply does not show any link between the order dated 3rd May, 2012 and 20th August, 2013 though copy of order dated 20th August, 2013 is annexed to the application.
