Original Application praying that this Hon'ble Court be pleased to pass an Ad-Interim Injunction restraining the Respondent, his agents or any one claiming through him in any manner from releasing the Tamil Film titled "JK ENNUM NANBANIN VAZKAI" on 15.01.2015 or on any other date in any format particularly in DVD format without settling the due amount of Rs.3,26,73,786/- pending disposal of the Arbitration proceedings.

These application have been filed for appointment of Advocate

Commissioner to seize and retain all DVDs of the Tamil Film viz "JK Enum
