2. Heard the learned counsel appearing on behalf of the petitioners and the learned Government Advocate (Criminal Side) appearing on behalf of the first respondent.

The contentions put forward by the learned counsel appearing on behalf of the petitioners are purely factual in nature and this Court cannot venture into conducting a mini investigation into the matter and it therefore does not fall within the ambit of its jurisdiction under Section 482 of Cr.P.C.
