The learned counsel for the petitioner submits that due to the covid-19 pandemic situation he is unable to surrender before concerned Court and executing sureties within a stipulated period as ordered by the Court. This petition has been filed by the petitioner seeking further extension of time for surrender.



3. Being satisfied with the reasons shown in the affidavit filed in support of the petition, the prayer sought for by the petitioner deserves to be considered favourably.

4. Accordingly, time is extended by a further period of two weeks from the date of receipt of a copy of this order for the petitioner to surrender before the concerned Court and execute the sureties. All other conditions remain unal
