Though pleadings are complete in the matter, learned counsel for the petitioner states that the petitioner prefers to file statutory appeals challenging the impugned orders of assessment passed in terms of the Tamil Nadu Value Added Tax Act, 2006.



2. Hence, in line with the decision of the Supreme Court in a series of judgments, viz., In Re: Cognizance for Extension of Limitation dated 23.03.2020, 06.05.2020, 10.07.2020, 08.03.2021 and M/s.SS Group Pvt. Ltd. V. Aaditiya J. Garg & another (Civil Appeal No.4085 of 2020 dated 17.12.2020) extending the limitation for filing of appeals, petitioner is granted 30 days time from today to file appeals. This is for the reason that the present Writ Petitions have been pending on the file of this Court since 11.01.2021.

3. Such appeals, if filed within the period as aforesaid, will be taken on file by the Appellate authority without reference to limitation, but ensuring all other statutory conditions and considered on merits and in accordance with law.

4. The Writ Petitions are disposed. No costs. Connected Miscellaneous Petitions are closed.
