COMMON ORDER

(The Common Order of the Court was made by R.Subbiah, J)

These Review Applications are filed to review the order dated 02.08.2019 passed by this Court in W.P.Nos.7979, 8816, 8341, 8386, 8385, 8826, 7986, 8387, 8822, 8210, 8934 and 8389 of 2019.

2. Upon hearing the learned counsel appearing for the parties and on a perusal of the order under review, we find that there is no error apparent on the face of the record. Therefore, we are not inclilned to entertain these review applications.

3. However, the learned Special Government Pleader appearing for the review applicants submitted that the review applicants may be permitted to find out the authenticity of the Community Certificates produced by the writ petitioners, as to whether they are genuine documents or bogus.

4. We are of the opinion that there is no need to give any specific direction with regard to the above request made by the learned Special Government Pleader. The review applicants are always at liberty to verify the documents as to the authenticity/originality of the same.

5. With the above observations, the Review Applications are closed. No costs. Consequently, W.M.Ps. are closed.
