2. Today, when the matter is taken up for hearing, the learned Additional Public Prosecutor would submit that charge sheet has been filed in this case and the victim girl is 6 years old and now, the case is pending for examination of witnesses. Hence, he opposed to relax the condition.

3. Considering the serious nature of the offence and age of the victim girl, this Court is not inclined to relax the condition

and accordingly, this Criminal Miscellaneous Petition stands dismissed. The same condition is to be continued until further orders.
