Writ Petition filed under Article 226 of the Constitution of India to issue a Writ of Mandamus, directing the Respondents 1 to 3 to Count half on the Service rendered by the Petitioner, as plot watcher on daily wage basis from 21.03.1983 till 29.06.2011 along with regular service rendered by him as Forest Watcher from 30.06.2011, till the date of his retirement namely 31.03.2015.
