ORDER

The petitioner has preferred a representation dated 19.09.2020 to the Revenue Divisional Officer, Coimbatore, to issue patta in his name in S.F.No.521 at Billichchi Village, Coimbatore North Taluk, Coimbatore, after making certain rectifications and modifications in the patta.

2. Heard the learned counsel for the petitioner. Mr.E.Balamurugan, learned Special Government Pleader takes notice for the respondents and makes a statement on written instructions that the enquiry for the purpose is scheduled to take place at 4.00 p.m., on 25.02.2021 in the Office of the Tahsildar, North Coimbatore District / second respondent. The said statement is recorded.

3. Inasmuch as the date for enquiry is fixed by the respondents, no direction is required to be given except that the second respondent / Tahsildar, North Coimbatore District is directed to hold an enquiry after issuing notices to all the parties who are likely to be affected by his decision, and after providing the parties a fair and effective hearing and to dispose of the said representation through a speaking order within a period of twelve (12) weeks from the date of service of order copy, subject to such time that may be lost in responsibilities connected with the ensuing General Election of the Tamil Nadu State Legislative Assembly, 2021.

4. The writ petition is disposed of accordingly. No costs.
